### **Board Meeting Minutes**

April 30, 2021 - via video conference



#### I. Welcome

Attendees: Chris Sears, Lauren Holcomb, Ted Beck, Lisa Olens, Shyam Kumar, Tony Lowden, Bonnie Holliday, Erika Mitchell, Lina Milan, Michele Neely, Ryan Hersh

a. Chris Sears called the meeting to order at 1:04 p.m.

#### II. Board Governance

- a. L. Milan moved to approve the minutes from the January 29, 2021 Board meeting. L. Olens seconded the motion. The minutes were approved unanimously.
- b. C. Sears welcomed Erika Mitchell, new board member. She introduced herself, and the group welcomed her to the SCSF.

#### III. Financial Report

- a. T. Beck gave the financial report and noted that grant funds had been expended and distributed as sub-grants to schools. He reminded all board members to make their annual donation to the SCSF.
- b. T. Beck gave an overview of the financial outlook of the organization. He indicated that the SCSF is reviewing our possibilities for revenue now that COVID-19 Relief funds have been depleted. We were recently approved as a nonprofit for the State of GA charitable giving program, which allows state employees to give through payroll deduction. We also just received a sponsorship to cover the expenses of the Shining Star Teacher program, giving \$50 gift cards to 25 teachers. Michele and Ryan are working on other sponsorship opportunities. Michele, Ryan, Tony, and Erika have been also working on a revised funding prospect list and methods for reaching individual donors. Finally, we have submitted several grant applications for funds for a reading initiative. Amending and extending the strategic plan will help us as we seek funds for programming.

#### IV. President's Report

M. Neely presented updates for the organization. She reported that several new schools had been approved for charter contracts, and she indicated that she would work with the SCSC to provide support for these schools. She reported that the Art of Connection Exhibition of Student Art was displayed on the SCSF website and winners were being selected. She indicated that the SCSF had secured a sponsor for the Shining Star Teacher program and had begun accepting nominations. Neely also reported on efforts to support tutoring and student wellbeing, communication with schools, and grant applications.

#### V. Strategic Plan and Goals for FY2022

a. M. Neely presented the proposed amended strategic plan and goals for FY2022 to the full board. There was discussion about removing the requirement of using CPF for all grants, depending on the purpose of the grant. The board was supportive of the amended and extended plan and the goals set.

b. L. Holcomb moved to approve the amended and extended strategic plan through FY2022.
 S. Kumar seconded the motion. The board approved the amended and extended plan unanimously.

### **Board Member Nomination**



July 30, 2021

**Yolanda Mack** has been nominated to serve a three-year term as a member of the Board of Directors for the State Charter Schools Foundation of Georgia by Chris Sears, effective July 31, 2021.

#### **Biographical Information**

Yolanda R. Mack is currently the Deputy District Attorney for the Sexual Assault Unit at the Fulton County District Attorney's Office. She is currently responsible for leading a team of Senior Assistant District Attorneys in prosecuting felony cases of sexual assault against adult victims.

Prior to joining the Fulton County District Attorney's Office, she was the Deputy Chief District Attorney for the Domestic Violence & Sexual Assault Unit in DeKalb County from 2017-2020. Her focus was prosecuting felony cases involving intimate partner domestic violence, adult sexual assault, and domestic violence homicides. Under her leadership, she received the Unit of the Year in 2019.

From 2007-2017, Ms. Mack was employed with the Fulton County District Attorney's Office, where she began as a Senior Assistant District Attorney and quickly rose through the ranks to a Chief Senior Assistant District Attorney responsible for prosecuting sex crimes and domestic violence cases in the Crimes Against Women & Children's Unit. She received the Attorney of the Year Award (2010) in the Major Crimes Unit where she prosecuted homicides and high-profile cases. She also received Attorney of the Year in that unit in 2016.

A graduate of Thurgood Marshall School of Law, Ms. Mack has dedicated her career to public service with an emphasis on victim-centered prosecution. She is currently a board member at the International Women's House (IWH), a domestic violence shelter, whose mission is to provide a safe haven and supportive services for women and children who are victims of domestic violence, sexual assault, and human trafficking. She is also a member of the DeKalb County Domestic Violence Task Force, the Sexual Assault Response Team (SART), and the Leadership DeKalb Class of 2021.

### **Board Member Nomination**





**Adria Welcher** has been nominated to serve a three-year term as a member of the Board of Directors for the State Charter Schools Foundation of Georgia by Chris Sears, effective July 31, 2021.

#### **Biographical Information**

Adria N. Welcher, Ph.D. is the Academic Program Director, an Assistant Professor of Sociology, and the Director of General Education at Morehouse College. At the College, she serves as the Parliamentarian for Faculty Council, Chair of the SouthEastern Undergraduate Sociology Symposium, a member of the Institutional Review Board, and an advisor to several registered student organizations. She also teaches the criminology course and supervises the Criminal Justice Minor. She is an active member of the American Sociological Association, the National Academic Advising Association, and the Southern Sociological Society where she is serving as a member of the Committee on Racial and Ethnic Minorities. She is very passionate about social justice issues and understanding inequalities. Her primary research interests are race and class inequities in educational outcomes and residential choices.

Dr. Welcher's public scholarship has been an active part of her dossier. She has served as a consultant on a Fair Housing Act discrimination claim in Minnesota. She was featured on the *While Black* podcast in 2019, discussing how black middle-class parents navigate their residential and educational options in metro Atlanta. She has also participated on two PBS telecasts – most recently on *PBS Newshour* discussing wealth inequalities between black and white middle class families. She was featured on the Georgia Public Broadcasting *A Seat at the Table* episode entitled, Stay Woke, focusing on colorblind racism. As a result of the Stay Woke episode, she was invited to present the opening lecture for the City of Chattanooga's Department of Multicultural Affairs Fair Housing Conference commemorating the 50th Anniversary of the Fair Housing Act.

Prior to coming to Morehouse, Dr. Welcher was an assistant professor of sociology at Georgia Gwinnett College. Adria Welcher earned her doctorate in Sociology from Emory University, and she also holds a BA in Theatre with a minor in Mathematics from Spelman College (cum laude), an MA in Higher Education from the University of Michigan, and an MA in Sociology from Stanford University.

Dr. Welcher is also very involved in her community. She is a member of the Leadership Dekalb Class of 2021, and she is an active member of Jack and Jill of America, Inc., having served as a two-term chapter president and as program director. She currently serves as the Southeastern Region Chair of the National Strategic Partnership Taskforce and as a member of the Southeastern Region Program Committee. In the past, she was a member of the Southeastern Region's Strategic Relevance and Value and Nominating Committees. She is also active in her sorority, Alpha Kappa Alpha Sorority, Inc., severing as a member of the Standards and Technology Committees. She is active at her church, as Chair of the Governance Committee, Coordinator of the New Member Ministry, Director of Christian Education, a member of the Youth Council, and any other role required of her as the "first lady." Dr. Welcher is also very involved in her children's schools and has been a member of the Junior League of Dekalb County, serving as the Public Relations and Community Outreach Chair and a member of the Nominating Committee.

Dr. Welcher is the proud wife of the Rev. Kamau Welcher and the mother of four wonderful children, including a son who is graduate from Howard University, a daughter who is a graduate from DeKalb School of the Arts, a son in high school, and a son in elementary school. She was raised Augusta, GA.

### FY2022 Strategic Goals Update – July 2021

#### Identity & Value

- Serving on Communications Committee and COVID-19 Task Force with the Georgia Charter Schools Association
- Serving on the BES Community Advisory Council
- Will establish Advisory Council, to include school leaders, after school starts

#### Fundraising

- Pursuing grant funds in a joint application with the SCSC for federal Teachers and School Leader Incentive Program to provide bonuses to effective leaders and teachers, with a preference for educators serving high needs schools.
- Pursuing grant funds from the State Fiscal Recovery Fund to provide 5,000 devices, technical assistance, and digital literacy training in partnership with InspirEDU.
- Pursuing grant funds from the GEER II fund to support school replication and development outside of Atlanta.
- Considering grant application for the federal Innovative Approaches to Literacy program as a consortium of schools.
- Applying for the Community Foundation of Greater Atlanta's Extra Wish program for books and book vending machine to support the Book Wagon and reading initiatives.
- Completed grant prospect spreadsheet and making contact with foundations.
- Planning for Donuts for Teachers this fall.

- Requested UGA Social Work/Public Health intern to assess wellbeing of state charter students and develop prioritized list of needs to address.

- Planning for Donuts for Teachers for the fall.
