

# Replication and Expansion Cohort Program 2024-25

Thank you for your interest in the Georgia Strategic Charter School Growth Initiative! The initiative, led by the State Charter Schools Foundation of Georgia, seeks to expand charter school opportunities for Georgia's children.

The Charter Growth Initiative's Replication and Expansion Cohort program targets existing charter schools that are considering replication or expansion in the next five years. Charter schools do not need an approved replication or expansion to apply. This unique cohort opportunity includes two phases. The first phase includes intensive strategic planning services with a national education consultant. The second phase offers technical assistance to take actionable steps to implement the strategic plan, petition preparation services, and facility and finance consulting services. Participants will identify their school/network's strengths and areas for growth and will leave with a plan to scale sustainably to serve more students. The program takes place over 12 months and includes in-person and virtual one-on-one consulting services and at least two inperson convenings with the cohort.

The Replication and Expansion Cohort Program is free of charge to four selected participant charter schools/networks in Georgia. Participants will be required to participate in all activities and pay for any travel expenses. This opportunity is funded by the State Charter School Foundation of Georgia's FY22 CSP SE Grant. All existing charter schools/networks in Georgia in good standing with their authorizer are encouraged to apply.

# **2024-25 Timeline**

June 24 Applications due at 5:00 p.m. ET (via the SCSF Grant Portal).

July 8-10 Applicant interviews.

By July 24 Cohort selected and notified.

Week of August 5 Cohort kick-off.

August – December Phase I – Long-range strategic planning and scaling, combination

of in-person and virtual meetings and at least one in-person cohort convening; participants will have a complete strategic plan at the conclusion (expect 5+ hours/week of engagement plus school

assignments). Services provided by Bellwether.

October – July Phase II – Strategic plan implementation, facility and finance

consulting, and/or petition planning, preparation, and submission for ready schools. This part of the program will start with a facility and finance needs analysis, followed by implementation support services starting in January. Services provided by GCSA's

Incubator and Facility Resource Center.

#### **Selection Criteria**

Participants for this cohort program will be selected through a competitive process. Applications will be reviewed by representatives from the Charter Growth Initiative partnership (SCSF, SCSC, Bellwether, and others). The application review team reserves the right to schedule an interview with prospective applicants to assess their readiness to participate in the cohort.

To be eligible, applicants must be a charter school/operator with at least one operational charter school in Georgia and remain in good standing with their existing charter school authorizer throughout the program. Charter schools may be authorized by a local school board or the State Charter Schools Commission of Georgia, and they may seek petition approval as a result of this program from any charter school authorizer in Georgia.

Applications will be rated on the following criteria:

- Responsiveness to community need Applicants should demonstrate their responsiveness to community need and demand by describing the engagement they have had with their community. The school/network model should show strong alignment with community need. Schools/networks planning to locate in one of the SCSC's geographic priority areas will be given priority for this cohort program. Applicants proposing to expand or replicate in an area of high charter school concentration must demonstrate strong community need for the unique model proposed.
- Growth mindset Applicants should demonstrate their interest in expanding (number of seats and/or additional grade band) or replicating (opening a new school based on the existing model) within the next 2-5 years. Priority will be given to schools currently eligible to expand or replicate through their authorizer or the State Charter Schools Commission of Georgia. Applicants should also express their willingness to engage in open, transparent conversations with technical assistance providers and to welcome feedback with an open mind.
- Commitment Applicants must identify 1-2 key individuals who will engage in the work of the program who are willing and able to devote at least 5 hours per week to meetings, convenings, and "homework." Applicants must agree to participate in all activities and events and remain responsive to technical assistance providers.
- Readiness Applicants must demonstrate their readiness to plan for expansion or replication. The evaluation team will review current and historical academic and operational performance, eligibility for expansion or replication, and mitigating factors. This cohort program is intended to support schools are various stages of readiness, but the applicant should demonstrate an initial plan or idea.

## **Submission Details**

Please submit applications for the Replication and Expansion Cohort Program by 5:00 p.m. ET on Monday, June 24, 2024. Applications must be submitted through the SCSF Grant Portal.

To submit an application, please start by creating an account in the grant portal and completing a profile (school information). If you have used our grant portal previously, please make sure your profile is updated with the correct contact information. After completing the profile, click the "Get Started" box to begin your application. In the application, you will answer any necessary questions

  - Overseeing the development of a financial model
